Constitution 組織

1. The board of directors (the "Board") of Petro-king Oilfield Services Limited (the "Company") hereby resolves to establish a remuneration committee of the Board (the "Remuneration Committee"). The constitution of the Remuneration Committee shall comply with the requirements of the Rules Governing the Listing of Securities (the "Listing Rules") on The Stock Exchange of Hong Kong Limited (the "Stock Exchange") from time to time. 百勤油田服務有限公司("本公司")董事會("董事會")現議決於董事會轄下成立一個薪酬委員會("薪酬委員會")。薪酬委員會的組成必須遵守香港聯合交易所有限公司("聯交所")不時制定的證券上市規則("《上市規則》")的要求。

Membership 成員

- 2. The members of Remuneration Committee shall be appointed by the Board and shall consist of not less than three members, a majority of whom should be independent non-executive directors. A quorum shall be two members, one of whom shall be an independent non-executive director. 薪酬委員會成員須由董事會委任,並由不少於三名成員組成,其中大部分應為獨立非執行董事。薪酬委員會的法定人數為兩人,其中一人須為獨立非執行董事。
- 3. The chairman of the Remuneration Committee shall be appointed by the Board and must be an independent non-executive director. 薪酬委員會主席須由董事會委任,並且須為獨立非執行董事。
- 4. The company secretary shall be the secretary of the Remuneration Committee. 薪酬委員會秘書為公司秘書。

Attendance at meetings 出席會議

5. Unless otherwise agreed by all the members of the Remuneration Committee, a meeting of the Remuneration Committee (the "**Meeting**") shall be called by at least fourteen (14) days' notice. A member may and, on the request of a

member, the secretary shall, at any time summon a Meeting. Notice shall be given to each member, at least fourteen (14) days before the date of the Meeting orally in person or in writing or by telephone or by telex or telegram or facsimile transmission at the telephone number or facsimile number or address from time to time notified to the secretary by such member or in such other means as the members may from time to time determine. Any notice given orally shall be confirmed in writing. Notice of Meeting shall state the time and place of the Meeting and shall be accompanied by an agenda together with other documents which may be required to be considered by the members for the purposes of the Meeting.

- 8. Resolutions of the Remuneration Committee at any Meeting shall be passed by a majority of votes of members if more than two members are present and by a unanimous vote if only two members are present. 任何薪酬委員會的決議如超過兩名成員列席,必須經由大多數列席成員投票贊成才能獲得通過;如列席成員人數只有兩名,則必須一致贊成才能通過。

Frequency of meetings

9. Meetings shall be held at least once a year. 會議次數須不少於每年一次。

Authority 權力

- 10. The Remuneration Committee is authorised by the Board to seek such further information from the management of the Company as it may require in order to enable it to discharge its duties.

- The Remuneration Committee is authorised by the Board to obtain outside legal or other independent professional advice and to secure the attendance of outsiders with relevant experience and expertise if it considers this necessary. 董事會授權薪酬委員會向外諮詢法律或其他獨立的專業意見;如有需要,可邀請具備相關經驗及專業知識的外界人士出席會議。

Duties 職務

- 12. The duties of the Remuneration Committee shall be: 薪酬委員會的職務如下:
 - (a) to make recommendations to the Board on the Company's policy and structure for all remuneration of directors and senior management and on the establishment of a formal and transparent procedure for developing such policy; 就本公司董事及高級管理人員^註的全體薪酬政策及架構,及就設立正規而具透明度的程序制訂此等薪酬政策,向董事會提出建議;
 - (b) to consult the chairman and/or chief executive about their remuneration proposals for other executive directors; 就其他執行董事的薪酬建議諮詢主席及/或行政總裁;

- (c) to have the delegated responsibility to determine the specific remuneration packages of all executive directors and senior management Note, including benefits in kind, pension rights and compensation payments, including any compensation payable for loss or termination of their office or appointment, and make recommendations to the Board of the remuneration of non-executive directors. The Remuneration Committee shall consider factors such as salaries paid by comparable companies, time commitment and responsibilities of the directors, employment conditions elsewhere in the group and desirability of performance-based remuneration; 獲董事會轉授以下職責,即釐訂全體執行董事及高級管理人員問的 特定薪酬待遇,包括非金錢利益、退休金權利及賠償金額(包括 喪失或終止職務或委任的賠償),並就非執行董事的薪酬向董事 會提出建議。薪酬委員會應考慮的因素包括同類公司支付的薪 酬、董事須付出的時間及董事職責、集團內其他職位的僱用條件 及是否應該按表現釐訂薪酬等;

- (f) to review and approve compensation arrangements relating to dismissal or removal of directors for misconduct to ensure that such arrangements are determined in accordance with relevant contractual terms and that any compensation payment is otherwise reasonable and appropriate;

13. Draft and final versions of the minutes of the Meetings shall be sent to all Remuneration Committee members for their comments and records respectively. The secretary or his representative shall circulate the minutes of Meetings and reports of the Remuneration Committee to all members of the Board.
